Hereby declare in the event of my death, or illness or injury that may impede my ability to perform my duties as the Chief Administrator of the Kajukenbo Self Defense Institute Worldwide (K.S.D.I.), or upon my retirement, I, Senior Grand Master Dechi Emperado want it known by all that my son, Grand Master Kimo Emperado Smith whom holds the rank of 9th degree under K.S.D.I., shall take over my role and responsibilities as the Chief Administrator of the K.S.D.I. Worldwide. In addition, my son Prof. Joe Emperado Smith shall assist GM Kimo Emperado Smith as needed and GM Glen Michael Fraticelli shall be appointed deputy to the Chief Administrator.

I was appointed Chief Administrator of the Kajukenbo Self Defense Institute (K.S.D.I.) by my brother Sijo Adriano D. Emperado, co-creator of the Kajukenbo style of self-defense and founder of the Kajukenbo Self Defense Institute Incorporated (K.S.D.I., Inc.) as established in the state of Hawaii and in being so named was also given the sole authority to make this proclamation and appoint my successor as the next Chief Administrator of the Kajukenbo Self Defense Institute (K.S.D.I.), Worldwide.

Be it known, there is no and will not be any named successor to Sijo Adriano D. Emperado, the only recognized K.S.D.I., 10th degree and this proclamation is made in no way to indicate or suggest by any means a successor to Sijo Emperado.

In the event GM Kimo Emperado Smith takes over my role and responsibilities as the Chief Administrator of the K.S.D.I. Worldwide, it will be his responsibility, as well as Prof. Joe Emperado Smith and GM Glen Fraticelli, to continue to work with the K.S.D.I Worldwide senior leadership, GM Council and the Emperado Family Council to honor Sijo Emperado's wish of keeping Kajukenbo alive forever through offering support to all Kajukenbo students and instructors. In addition, GM Kimo Emperado Smith, Senior leadership, GM Council and K.S.D.I. Worldwide shall work together to develop a K.S.D.I. Promotion Board for 8th and 9th degree rank promotions and certification.

In closing, let it be known that the name "Emperado" or the Kajukenbo Self-Defense Institute (K.S.D.I.) shall not be used by any person or organization outside of the Emperado bloodline for personal or business gain without the approval and consent of the K.S.D.I. Worldwide and the Emperado Family Council.

Lastly, my decision to issue this proclamation is based on the need to keep Kajukenbo alive forever and flourishing for all its practitioners and the future generations to come.
